# **CW** Tree Planting Initiative

**222.** Consideration was given to tree provision/tree planting scheme for Cullompton (Supporting Paper J to the agenda)

**RESOLVED:** Cullompton Town Council is generally supportive of tree planting and accepts Mid-Devon District Council's Tree Planting Initiative at Crow Bridge/Green on the understanding that Mid-Devon District Council responds in writing to the following points before any tree planting takes place:

1. Cullompton Town Council wishes to highlight that Crow Green is a good amenity for the local community, being historically a large open space and very popular with local residents including children, who do use this regularly e.g. for playing football, walking, dog walking etc. The Cullompton neighbourhood Plan includes a section relating to the protection of open/green spaces which was included with the aim of stopping public areas of green disappearing. This should therefore be considered by Mid-Devon District Council when looking to progress with this scheme.

Administrators Note: Excerpt from page 46 of the Neighbourhood Plan (below) refers –

## Local Green Space

9.11 A recent audit and assessment of local play areas and parks has been carried out on behalf of the Town Council. It looked at all local play areas and 'pocket parks' and took a view as to whether they were fit for purpose, capable of being maintained properly and worthy of protection. The conclusions from this assessment are reflected in the list of local green spaces in Policy EN03. The Local Plan through its policy DM24 recognises the value of local green space and acknowledges that "sites which are particularly important to local communities may be designated as Local Green Space, through the preparation of local or neighbourhood plans".

9.12 We are pleased to recognise that the town area has several small green areas that contribute significantly to the appearance and character of the local area and provide for a range of informal community leisure activities of the local population, not least providing somewhere safe for young children to play, as many of them do. Cullompton Town Council will be exploring how to reinforce their value as part of a network of green infrastructure throughout the town. As Natural England has reminded us, "green infrastructure can perform a range of functions including improved flood risk management, provision of accessible green space, climate change adaptation and biodiversity enhancement"42.

9.13 The areas identified in Policy EN03 meet the criteria of the NPPF (para. 100) which enables them to be designated as 'local green space' i.e.:

- where the green space is in reasonably close proximity to the community it serves;
- where the green area is demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and
- where the green area concerned is local in character and is not an extensive tract of land.

9.14 A thorough assessment of potential sites was carried out by the Neighbourhood Plan Steering Group to assess whether the 'candidate' sites met the NPPF criteria, including being demonstrably special to the local community. Consistent with the approach of Local Plan policy DM24, those 'green' sites that are valued primarily for their sport and recreational purposes, are identified on map 6 (page 48) and subject to a separate Policy WL01. The sites that are subject to Policy EN03 are designated as Local Green Space because they are highly valued green areas that contribute significantly to the amenity of their neighbourhood, and the community wants to ensure they continue to do so for a very long time. A Site Assessment Report43 presents our site by site analysis and conclusions.

9.15 The sites we consider 'qualify' as local green space and to which Policy EN03 should apply are: Bilbie Close/Crow Bridge - a stretch of grass that provides for a range of informal leisure activities. It is bordered on two sides by a local brook.;...

- 2. It is understood that the trees will predominantly be planted in the corner of the Green close to Tufty Park;
- 3. There is a watercourse (Leat/Millstream) that runs across part of this green area and there is a concern that the area is prone to flooding on occasion; it is requested that consideration should be given by Mid-Devon District Council to the types of trees that would be suitable for planting and their associated ability to absorb water;
- 4. Consideration by Mid-Devon District Council should be given as to how the trees will be protected from damage/vandalism once planted, particularly as football is played on the Green;
- 5. It is expected that Mid-Devon District Council will be responsible for:

- i) Purchase (supply) of any trees;
- ii) Planting of and the future maintenance of said trees.

NB: It was further noted that there is Japanese Knotweed and Giant Hogweed at Crow Green/Bridge and MDDC may need to look to address this before any planting is started at this location.

#### CW Christmas Event

223. Consideration was given as to whether a dedicated Working Group should be set up to review the Christmas 2021 event arrangements, with the purpose of identifying any organisational learning. It was:
